

**1. DESCRIPTION**

The U.S. Consulate General Chiang Mai requires preventive maintenance services for medium voltage switches, and transformers in a safe, reliable, and efficient operating condition worldwide. See section 6.2.3 for security requirements.

**1.1. Type of Contract**

This is a firm fixed price contract. Prices for all Contract Line Item Numbers (CLIN) shall include proper disposal of toxic substances as per Item 8.4 where applicable. No additional sums will be payable for any escalation in the cost of materials, equipment or labor, or because of the contractor's failure to properly estimate or accurately predict the cost or difficulty of achieving the results required. The contract price will not be adjusted due to fluctuations in currency exchange rates.

**1.2. Period of Performance**

The contract will be for a period of one-year, with a maximum of four one-year optional periods of performance and will commence upon substantial completion of the construction of the facility. The work of this contract is expected to occur in August.

**2. PRICING**

The rates below include all costs associated with providing preventive maintenance services in accordance with the attached scope of work, and the manufacturer's warranty including materials, labor, insurance (see FAR 52.228-4 and 52.228-5), overhead, profit and GST (if applicable).

VALUE ADDED TAX

Value Added Tax (VAT) is not applicable to this contract and shall not be included in the CLIN rates or Invoices because the U.S. Embassy has a tax exemption certificate from the host government.

VAT Exemption document will be processed through Ministry of Foreign Affairs for the order which has the total price excludes VAT at or more than 5,000 THB for local VAT registered contractor under Section 82/3 of Thai Revenue Code only. The contractor will receive the document within 150 days after submitting the invoice.

OFFERS AND PAYMENTS IN U.S. DOLLARS

U.S. firms are eligible to be paid in U.S. dollars. U.S. firms desiring to be paid in U.S. dollars should submit their offers in U.S. dollars. A U.S. firm is defined as a company which operates as a corporation incorporated under the laws of state within the United States.

Foreign Firms – any firms, which is not a U.S. firm, is a foreign firm. Any firm that does not meet the above definition of the U.S. firm shall submit its prices and receive payment in local currency.

### 3. NOTICE TO PROCEED

Once the facility is substantially complete (currently expected to occur on July 31, 2025) and the contractor has submitted acceptable insurance certificates and copies of all applicable licenses and permits the Contracting Officer will issue a Notice to Proceed. The Notice to Proceed will establish a date (a minimum of ten (10) days from date of Contract award unless the Contractor agrees to an earlier date) on which performance shall start.

### 4. EQUIPMENT AND PERFORMANCE REQUIREMENTS

4.1. The Consulate in Chiang Mai requires the Contractor to maintain the following equipment in a safe, reliable and efficient operating condition.

*The Consulate General is supplied with 25kV 600A service. This enters the compound at the demarcation room at the Service entrance building. That feed proceeds through a concrete encased duct bank to the medium voltage switch gear, providing the disconnecting means for the medium voltage transformer. Both are located in the utility building service yard.*

4.2. The Contractor shall provide all necessary managerial, administrative and direct labor personnel, as well as all transportation, equipment, tools, supplies and materials required to perform inspection, maintenance, and component replacement as required to maintain the systems in accordance with this work statement. Under this Contract the Contractor shall provide:

- The services of trained and qualified technicians to inspect, adjust, and perform scheduled preventive maintenance.

#### 4.3. Performance Standards

The chillers shall be clean and in good operating condition upon completion of the service. The preventive maintenance service shall result in the parts of the system serviced being in a condition to operate efficiently and effectively.

### 5. HOURS OF PERFORMANCE

5.1. The Contractor work schedule shall take into consideration the hours that the staff can effectively perform their services without placing a burden on the security personnel of the Post. The Contractor shall deliver standard services between Monday and Friday. No work shall be performed on US Government and local holidays. A list of the holidays can be provided upon request.

5.2 The Contractor shall schedule and arrange work to cause the least interference with the normal Post operations. In those cases where some interference is unavoidable, the Contractor shall make every effort to minimize the impact of the interference and its effects on the occupants or users. In developing the work schedules, the Contractor shall consider and rely on: (1) contract requirements, (2) previous experience; (3) industry standards and guides; and (4) Consulate input. All work schedules required by this statement of work shall be electronically documented and updated and made available to the Contracting Officer's Representative (COR) upon request, verbal or written. If the COR determines that the Contractor's schedule conflicts with critical Post operations, the Contractor shall modify the schedule as required.

5.3 Planned outages. A planned system transfers shall be scheduled and approved by the Facility Manager. The contractor must schedule work to maintain flexibility as system transfers from utility power to generator power may not be granted on the date(s) requested. The Contractor shall accomplish the transfer work in a coordinated effort within the planned schedule. The intent is to schedule the transfer from utility power to generator power prior to the start of normal operations at Post, and then to transfer from generator power to utility power at the end of normal operating hours. Notice of changes to the approved transfer schedule will be provided to the Contractor by the Consulate not less than 24 hours or as technically feasible before the scheduled event. Shutdown schedule changes required by the Consulate and made with sufficient notice to the Contractor shall be made at no additional cost to the Consulate.

Electrical shutdowns and operation of electrical breakers shall be accomplished only by qualified personnel and upon advance approval from the Facility Manager. Where fire protection, detection, or evacuation alarms are affected, advance written approval of the Facility Manager shall be obtained. Proper lock out/tag out procedures shall be followed to maximize safety. The Contractor shall supply all lock out/tag out materials. Power shall be maintained to all operational loads during normal working hours and to all critical loads at all times, except where otherwise approved by the Facility Manager.

5.4 Logistics Planning. The Contractor shall be responsible for coordinating all logistics associated with the shipment of tools, materials, and equipment to and from the work site. This includes adequate coordination with overseas diplomatic missions to determine shipment planning and execution requirements, as required and as applicable.

## **6. ACCESS TO GOVERNMENT BUILDINGS AND STANDARDS OF CONDUCT**

6.1 General. The Contractor shall designate a representative who shall supervise the Contractor's technicians and be the Contractor's liaison with the U.S. Consulate General Chiang Mai. The Contractor's employees shall be on-site only for contractual duties and not for any other business or purpose. Contractor employees will be given access to the equipment and equipment areas and will be escorted by Consulate personnel.

6.2 Personnel Security. The Government reserves the right to deny access to U.S.-owned and U.S.-operated facilities to any individual. The Contractor shall provide the names, biographic data and police clearance on all Contractor personnel who to be used on this Contract prior to their utilization. Submission of information shall be made within 30 days of award of contract. No technician will be allowed on site without prior authorization. This includes cleared personnel if advance notice of visit is not given at least one week before the scheduled visit.

6.2.1 Vehicles. Contractor vehicles will not be permitted inside the Consulate compound without prior approval. If vehicle access is necessary, submit contractor vehicle information (Make, Model, License Plate #) along with a written justification as to why access is necessary. This shall be submitted to the Facility Manager at least one (1) week prior to the visit.

6.2.2 Government shall issue identity cards to Contractor personnel, after they are approved. Contractor personnel shall display identity card(s) on the uniform at all times while providing services under this contract. These identity cards are the property of the U.S. Government. The Contractor is responsible for their return when departing the consulate grounds, or when requested by consulate security or the COR. The Government reserves the right to deny access to U.S.-owned and U.S.-operated facilities to any individual.

6.3 Security Clearances. All Work under this contractor that are designated as non-CAA areas may be performed by un-cleared American or local workers.

## 6.4 Standards of Conduct

6.4.1 General. The Contractor shall maintain satisfactory standards of employee competency, conduct, cleanliness, appearance, and integrity and shall be responsible for taking such disciplinary action with respect to employees as may be necessary. Each Contractor employee shall adhere to standards of conduct that reflect credit on themselves, their employer, and the United States Government. The Government reserves the right to direct the Contractor to remove an employee from the worksite for failure to comply with the standards of conduct. The Contractor shall immediately replace such an employee to maintain continuity of services at no additional cost to the Government.

6.4.2 Neglect of Duties. Neglect of duties is unacceptable. This includes sleeping while on duty, unreasonable delays or failures to carry out assigned tasks, conducting personal affairs during duty hours and refusing to render assistance or cooperate in upholding the integrity of the worksite security.

6.4.3 Disorderly Conduct. The Contractor shall not condone disorderly conduct, use of abusive or offensive language, quarreling, and intimidation by words, actions, or fighting. Also included is participation in disruptive activities that interfere with normal and efficient Government operations.

6.4.4 Intoxicants and Narcotics. The Contractor shall not allow its employees while on duty to possess, sell, consume, or be under the influence of intoxicants, drugs or substances which produce similar effects.

6.4.5 Criminal Actions. Contractor employees may be subject to criminal actions as allowed by law in certain circumstances. These circumstances include but are not limited to the following actions: falsification or unlawful concealment, removal, mutilation, or destruction of any official documents or records or concealment of material facts by willful omission from official documents or records; unauthorized use of Government property, theft, vandalism, or immoral conduct; unethical or improper use of official authority or credentials; security violations; organizing or participating in gambling in any form; and misuse of weapons.

6.4.6 Key Control. The Contractor will not be issued any keys. The keys will be checked out by a Consulate escort on the day of service requirements.

6.4.7 Notice to the Government of Labor Disputes. The Contractor shall inform the COR of any actual or potential labor dispute that is delaying or threatening to delay the timely performance of this contract.

## 7. Provision of Personnel

7.1 Qualified Staff. This statement of work requires the awarded contractor to provide qualified and licensed technicians as stated in the following stipulations. In addition, the contractor will be responsible for providing all required information listed in this section.

1. The Contractor must provide company as well as the individual technicians documentation of experience maintaining medium voltage electrical equipment.
2. The Contractor must provide a valid copy of the technician's Electrical Masters Licenses, Electrical Journeyman's Licenses or equivalent for the personnel performing work on site. These licenses are only accepted if issued by a State or Local Licensing Authority in which the contractor's business operates, or if accepted by their area's Licensing Authority. Licenses will be verified prior to acceptance of a proposal. A qualified Electrical Journeyman, or above, is required to perform switchgear inspections, function testing, and/or system operations, in accordance with this work statement. A qualified Electrical Journeyman, or above, is required to be on site when any work is being performed under this contract.
3. The contractor must provide copies of Training Certificates in the Fundamentals of Electrical Safety based on NFPA 70E standards, or equivalent, for all proposed on-site personnel. This training must have been completed within one year prior to the start of the contract. NFPA 70E defines a qualified person as one who has skills and knowledge related to construction and operation of electrical equipment and installations. The contractor must demonstrate that all personnel assigned to perform the tasks, described in this scope, are trained as defined by NFPA 70E, Article 110.3. A Qualified Person has received safety training to recognize and avoid all hazards involved. All performing technicians and engineers must be formally trained to comply with NFPA-70E guidelines and provide documentation of successful course completion. Recertification is required at three (3) year intervals. The contractor shall furnish all tools, test equipment, arc-flash PPE, and electrical safety PPE required by NFPA 70E to comply with this statement of work. The contractor will properly supervise all site personnel who are trained and qualified to work on MV systems. Working voltages for the equipment being maintained as part of this scope is 10kV - 35kV, line to line.
4. We understand that personnel changes may be necessary throughout the duration of this project. If the awarded contractor must make personnel changes or substitutions, the new members will be required to meet all stipulations as stated

above. The notification of changes must be made to COR. Approval must be granted by COR prior to performing any work. Failure to receive approval will result in unauthorized individual(s) being removed from Post at the contractor's expense.

7.2 Safety. Safety is the highest priority on this and all OBO/CFSM/FAC projects. The contractor shall direct all of those under his charge to work safely. A Work Hazard Assessment shall be performed at each location prior to any work being performed. All safety concerns shall be brought to the attention of the Post Safety and Health Officer (PSHO) and/or the COR.

## **8. SCHEDULED PREVENTIVE MAINTENANCE**

8.1 The Contractor shall perform preventive maintenance as outlined in Exhibit A - STATEMENT OF WORK. The intent of this scope is to ensure the operational readiness of compound Medium Voltage (MV) equipment. The awarded contractor must complete all aspects of this work statement. This entire work statement, each portion or step, applies to each individual MV demarcation switch to the step-down Transformer at each location, inclusive.

8.2. The Contractor shall provide trained technicians to perform the service at frequencies stated in Exhibit A and on the equipment called out in this SOW. The technician shall sign off on every item of the checklist and leave a copy of this signed checklist with the COR or the COR's designate after each maintenance visit.

### **8.3 Maintenance:**

1. Four weeks prior to on-site work, coordinate with the Facility Manager to schedule the work including the scheduled transfer from the utility source to generator power. The Utility Company may need to de-energize equipment so that the demarcation switchgear/switch is completely de-energized.
2. Discuss history of MV equipment service and note in the report any known maintenance or repair actions performed on the system in the past five years, where applicable.
3. Contractor personnel must familiarize themselves with site power conditions, related compound power anomalies, and power distribution concerns.
4. Verify Post's existing One-Line Diagram is posted for access in the associated switchgear room. Make corrections necessary to reflect the current configuration.
5. Prior to equipment testing, ensure that Post generator system(s) and auto-transfer switch(s) are in automatic mode. Confirm adequate fuel levels in the generator day tanks.
6. Follow all manufacturer's recommended safety practices and requirements. An electrical approved fire extinguisher (Class "C") and all NFPA 70E required PPE for the

rated voltages and available fault currents must be present and in use. All safety equipment must be well maintained and meet the requirements for periodic inspection/certification.

7. Perform a visual inspection of the entire MV distribution system. Include transformer(s), demarcation disconnect switch, distribution cables, fuse holders, terminals, insulators, lightning arrestors, etc.
8. Perform infrared (IR) scanning and inspection of all energized MV equipment per NETA thermographic survey procedures and guidelines. Correct hotspot connections as applicable. Include in the final report only those IR photos that note a discrepancy or correction. Label all photographs.
9. Perform Lock Out/Tag Out procedures on all incoming medium voltage sources and on low voltage distribution breakers to prevent back feeding (***Manufacturer data DOES NOT require breakers to be racked out to disable automatic operation. By placing a lock within the provided lock out location, a mechanical break is provided, permanently disabling the breaker's operational ability. Post prefers this method over racking breakers. If the contractor is willing to accept responsibility for repair and replacement of the circuit breaker or any component due to racking the breaker in or out, at no extra cost, Post will approve of the method).***
10. For reporting purposes, photo document the MV isolation. Include photographs of LOTO, use of PPE, and the installation of safety grounds. Label all photographs..
11. Draw oil samples on all MV equipment. Conduct all manufacturer recommended tests.
12. Perform general maintenance (clean, adjust, and lubricate as required) the entire MV system from the demarcation switch to the step-down transformer. Examine closely for signs of carbon tracking and document all findings.
  - a. NOTE: The demarcation switch or switchgear is owned and maintained by the Local Utility Company
13. Correct any minor deficiencies found using Post materials.
14. Provide list of repairs recommended and recommended spare parts.
15. Ensure the total voltage drop from the utility building to the main building is less than 3% of nominal. Raise/lower the generator output as required. Match the MV transformer output voltage to within 3-volts of the compound diesel generator voltage output.
16. The contractor shall note in the final report: defects, deficiencies, violations pertaining to equipment operation, safety hazards, safety code non-compliance. Note the applicable code article in reference to the stated violation.
17. Re-energize the system and restore to automatic operation unless a noted safety

concern exists. Upon encountering a hazardous situation, either pre-existing or resulting from work performed under this scope, immediately contact the Post Facility Manager or Contracting Officer Representative (COR).

18. Conduct an Out-brief with the site Facility Manager, or Facility Maintenance Representative, noting work completed and any safety concerns.

#### 8.4 REPAIRS

8.4.1 Exclusion. This contract does NOT include repair of equipment and replacement of hardware. Hardware replacements will be separately priced out by the Contractor for the Government's approval and acceptance. The Government has the option to accept or reject the Contractor's quote for parts and reserves the right to obtain similar spare parts from other competitive sources. If required by the Government, the Contractor shall utilize Government-purchased spare parts, if awarded the work. Such repairs/replacements will be accomplished by a separate purchase order. However, this exclusion does not apply if the repair is to correct damage caused by Contractor negligence.

8.4.2. Replacement/repair of any electronic or electrical parts shall be approved by the COR prior to installation of the part. If the Contractor proceeds to replace any electronic or electrical parts without COR approval, the Contractor shall de-install the parts at no cost to the Government.

#### 8.5 Replacement Parts, Materials and Supplies

The Contractor shall provide a list of manufacturer's recommended replacement parts. The contractor shall inventory the current supply of spare parts and make a list of missing items. The contractor is responsible for ensuring all hazardous wastes are disposed of in accordance with local laws. After proper disposal the contractor must show proof of authorized disposal of these toxic/hazardous substances.

### 9. DELIVERABLES

Provide a typewritten report to Post Facilities Manager containing following:

- a) System information (make, model, all devices types)
- b) Pass/Fail of each feature and type of component tested. If a device fails, note device type, address and location within Post
- c) Any comments on system (or device) condition pertaining to service life and dependability.
- d) Full printout of any testing.

## 10. INSURANCE REQUIREMENTS

10.1 Personal Injury, Property Loss or Damage (Liability). The Contractor assumes absolute responsibility and liability for any and all personal injuries or death and property damage or losses suffered due to negligence of the Contractor's personnel in the performance of this Contract

The Contractor's assumption of absolute liability is independent of any insurance policies.

10.2 Insurance. The Contractor, at its own expense, shall provide and maintain during the entire period of performance of this Contract, whatever insurance is legally necessary

### Workers' Compensation and Employer's Liability

The Contractor agrees to provide all employees with worker's compensation benefits as required under local laws (see FAR 52.228-4 "Worker's Compensation and War-Hazard Insurance Overseas").

## 11. LOCAL LAW REGISTRATION

If the local law or decree requires that one or both parties to the contract register the contract with the designated authorities to insure compliance with this law or decree, the entire burden of this registration shall rest upon the Contractor. Any local or other taxes which may be assessed against the Contract shall be payable by the Contractor without Government reimbursement.

## 12. GOVERNMENT INSPECTIONS AND QUALITY ASSURANCE

12.1 Plan. This plan is designed to provide an effective surveillance method to promote effective Contractor performance. The QAP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the Contract. The role of the Government is to conduct quality assurance to ensure that Contract standards are achieved.

12.2 Surveillance. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

12.3 Standard. The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212-4, Contract Terms and Conditions-Commercial Items), if any of the services exceed the standard.

12.4. Procedures.

12.4.1 If any Government personnel observe unacceptable services, either incomplete work or required services not being performed, they will immediately contact the COR.

12.4.2 The COR will complete appropriate documentation to record the complaint.

12.4.3 If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.

12.4.4 If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.

12.4.5 The COR shall, as a minimum, orally notify the Contractor of any valid complaints.

12.4.6 If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor shall notify the COR. The COR will review the matter to determine the validity of the complaint.

12.4.7 The COR will consider complaints as resolved unless notified otherwise by the complainant.

12.4.8. Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

### **13. TRANSITIONS/CONTACTS**

Within 30 days after contract award, the Contracting Officer may ask the contractor to develop a plan for preparing the contractor to assume all responsibilities for preventive maintenance services. The plan shall establish the projected period for completion of all clearances of contractor personnel, and the projected start date for performance of all services required under this contract. The plan shall assign priority to the selection of all supervisors to be used under the contract.

### **14. SUBMISSION OF INVOICES**

The Contractor shall submit an invoice after each preventive maintenance service has been performed. Invoices must be accompanied by a signed copy of the Maintenance Checklist for the work performed including parts replacement and break down calls, if any. No invoice for preventive maintenance services will be considered for payment unless accompanied by the relevant documentation.

The Contractor should expect payment 30 days after completion of service or 30 days after receipt of invoice at the Consulate payment office, whichever is later. Invoices shall be sent to [ChiangmailInvoices@state.gov](mailto:ChiangmailInvoices@state.gov) .

## EXHIBIT A - - Statement of Work

### SAFETY & SPECIAL INSTRUCTIONS:

- Apply appropriate personal protective equipment (PPE) and follow safe electrical work practices. See NFPA 70E or CSA Z462.
- Turn off all power supplying this equipment before working on or inside equipment.
- Always use a properly rated voltage sensing device to confirm power is off.
- Inspect, maintain, and replace parts with all power sources disconnected and locked in the OPEN position.
- Ensure there is no backfeed through any feeder circuit.
- Review and follow the manufacturer's instructions.
- Record results in the equipment history log.
- Report all incidents and near miss incidents to COR and assist as requested in the investigation and corrective action.

At a minimum, the following work shall be completed:

### Notes:

- Contractor shall submit to the COR for review, work sheet/checklist that will be used for performing maintenance service.
- A discrepancy report shall be submitted to the COR immediately upon discovery of any condition that could result in equipment failure.
- Test and inspection report shall be submitted to the COR within three days of completing work.

### Annual Maintenance Schedule

#### Switch:

1. Examine the exterior of the switch for any damage.
2. De energize the primary circuits before cleaning.
3. Check all connections. Re-torque to manufacturer's specifications.
4. Perform a standard 60-cycle hi-pot test to measure insulation integrity. Refer to Table 1 for hi-pot test values.
  - a. To avoid damage during the test, disconnect the instrument transformers and remove the fuses.
  - b. Apply the voltage to each phase individually for one minute, with the other two phases and the enclosure grounded.

- c. If the test is unsuccessful, inspect the insulators for leakage paths. If necessary, clean the surface of the insulator(s) and test again.

- 5. Inspect connections and control wiring for symptoms that might indicate overheating or weakened insulation. Inspect the devices and their contacts for dust or dirt. Wipe them clean.
- 6. Check control wiring connections for tightness and damage.
- 7. Manually operate mechanical moving parts such as switch assemblies, interlocks, and doors.
- 8. Check all bus areas, grille work and air passages for obstructions and dirt accumulation
- 9. Check the condition of the ground system.
- 10. Verify heaters and thermostat function correctly
- 11. Check condition of all components, including surge arrestors, fuses, parking ball,
- 12. Check door, door lock, gaskets. Etc.
- 13. Clean the exterior of the switch and operating mechanism.
- 14. Clean up area, remove tags, and return to service.
- 15. Fill out maintenance checklist and report deficiencies.
- 16. Provide a narrative summary of all findings, and conditions.
- 17. Provide the Post Facility Manager with a Bill of Materials (BOM) noting any required or suggested material replacements not presently onsite, along with the item's part number, unit price, and availability.

Transformer

- 18. Perform Lock-out/Tag-out the transformer input power and verify a de-energized and safe working condition prior to accessing internal transformer components. Provide a Lock-out/Tag-out SOP noting power isolation points and isolation steps in the final report.
- 19. Clean unit inside and out with a vacuum cleaner. Use low pressure dry air if necessary.
- 20. Ensure cabinet airflow.
- 21. Replace air filters as applicable.

22. Check and replace vibration isolation pads if applicable.
23. Thoroughly clean the tank cover and remove the handhole cover before removing.
24. Check underside of the cover for signs of moisture.
25. Look inside the transformer for blown fuses, broken leads, or loose parts.
26. Inspect all connections, components, and internal wiring for signs of overheating or damage.
27. Check bushings for damage.
28. Check for water/moisture at bottom of the tank.
29. Inspect spacing and rigidity of conductors.
30. Check for voltage creeping over insulating surfaces as indicated by tracking or carbonizing.
31. Check the transformer for signs of moisture on the windings, leads, or insulation. If moisture is found the transformer should be dried and the condition reported to the COR.
32. Spot-check all power connections for proper torque, and connection tightness. Exercise all circuit breakers. Resistance checks all semiconductor power modules.
33. Check fans, motors and other auxiliary devices for proper operation; where applicable.
34. Check the condition of the ground system and replace any worn or failing components with site spares.
35. Check and verify system output voltage adjustments. Check all logic adjustments, meter parameters and settings.
36. Megger check the unit. Record the results.
37. Perform all function tests (**REPO, Over/Under Voltage**) and calibrate unit.
38. Restore the transformer to its online condition. If any discrepancies remain, which prohibit the unit from supporting the load, the contractor's technician must notify the COR and post FM of these discrepancies and the units bypass condition immediately. Ensure proper system operation and work acceptance prior to leaving site.
39. Test all transformer alarms and remote alarm panels.
40. Provide a narrative summary of all findings, and conditions. Include all input and output voltage, amperage, and frequency readings.

52.229-11 TAX ON CERTAIN FOREIGN PROCUREMENTS – NOTICE AND REPRESENTATION (JUN 2020)

Specified Federal procurement payment means any payment made pursuant to a contract with a foreign contracting party that is for goods, manufactured or produced, or services provided in a foreign country that is not a party to an international procurement agreement with the United States. For purposes of the prior sentence, a foreign country does not include an outlying area.

United States person as defined in 26 U.S.C. 7701(a)(30) means—

- (1) A citizen or resident of the United States;
  - (2) A domestic partnership;
  - (3) A domestic corporation;
  - (4) Any estate (other than a foreign estate, within the meaning of 26 U.S.C. 701(a)(31));
- and
- (5) Any trust if—

(i) A court within the United States is able to exercise primary supervision over the administration of the trust; and

(ii) One or more United States persons have the authority to control all substantial decisions of the trust.

(b) Unless exempted, there is a 2 percent tax of the amount of a specified Federal procurement payment on any foreign person receiving such payment. See 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c) Exemptions from withholding under this provision are described at 26 CFR 1.5000C-1(d)(5) through (7). The Offeror would claim an exemption from the withholding by using the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, available via the internet at [www.irs.gov/w14](http://www.irs.gov/w14). Any exemption claimed and self-certified on the IRS Form W-14 is subject to audit by the IRS. Any disputes regarding the imposition and collection of the 26 U.S.C. 5000C tax are adjudicated by the IRS as the 26 U.S.C. 5000C tax is a tax matter, not a contract issue. The IRS Form W-14 is provided to the acquiring agency rather than to the IRS.

(d) For purposes of withholding under 26 U.S.C. 5000C, the Offeror represents that—
