It is important to make sure the submission is made in specific size and format; in Adobe Acrobat (pdf) file format. The file size must not exceed 25MB. If the file size should exceed the 25MB, the submission must be made in separate files and attached to separate emails with less than 25MB each.

DESCRIPTION/SPECIFICATIONS/WORK STATEMENT

I. The contractor shall provide one-year software license subscriptions and maintenance services for the existing Cisco network enterprise core switch, Next-generation firewall (NGFW) and Cisco Identity Services Engine (ISE).

The services include the continued support of Cisco Smart Licensing for the Cisco Next-Generation Firewalls (Models: NGFW 1120, 1140, and 2120), along with comprehensive maintenance services for both the Cisco Next-Generation Firewalls and the Cisco Catalyst 9400 Core Switch (Model: C9400), as well as Cisco Identity Services Engine (ISE) version 3.3. This support will ensure that the network infrastructure remains secure, up-to-date, and fully operational, providing seamless performance and adherence to industry standards. The service period is one year from the date which is specified in the contract.

The software licenses shall be compatible with existing equipment and meet the following minimum specification requirements:

Vendors may submit quotations for equivalent items, provided those items meet all of the salient physical, functional, and performance characteristics specified by this solicitation and as described in FAR [52.211-6](#).

The Contractor shall utilize monitoring tools to track the health and status of both Cisco 9400 Core Switch and Cisco Next-Generation Firewall, ensuring real-time visibility of network performance and security posture.

The Contractor shall ensure regular backups of configuration files, system settings, and security policies. Test recovery procedures shall be provided to minimize downtime in the event of failure or breach.

The Contractor shall stay updated on the lifecycle status of all devices and plan timely upgrades or replacements to avoid any security and performance risks.

The Contractor shall provide necessary training for network administrators and security teams on best practices, troubleshooting, and response protocols for maintaining the devices and handling network security incidents. The Contractor shall provide detailed reports on maintenance activities, incidents, updates, and system performance.

The maintenance services for each equipment must meet all stated requirements and shall not be less than the following:

1. Cisco 9400 Core Switch

- Regularly apply the latest firmware and software patches to address security vulnerabilities, improve functionality, and enhance system performance.
- Periodically review and optimize the switch configuration to ensure efficient network traffic management, high availability, and low latency.
- Monitor and assess hardware components (e.g., power supplies, fans, and network modules) to ensure proper functionality and early detection of any hardware failures.

- Continuously monitor traffic flow, network bandwidth utilization, and latency to identify and resolve potential bottlenecks or performance issues.
- Test and validate network redundancy configurations, including link aggregation, spanning tree protocol (STP), and failover procedures, to ensure business continuity in case of hardware or network failures.
- Review and update access control lists (ACLs), port security, VLAN configurations, and other security settings to prevent unauthorized access and mitigate network threats.
- Maintain up-to-date documentation for the network configuration and provide detailed reports on system health, performance metrics, and any incidents or outages.
- Provide detailed reports on maintenance activities, incidents, updates, and system performance.

2. Cisco Next-Generation Firewall

- Regularly review and update firewall rules and security policies to adapt to evolving security needs, prevent unauthorized access, and ensure compliance with industry standards.
- Continuously update malware signatures, threat intelligence feeds, and intrusion prevention systems (IPS) to protect against emerging threats such as zero-day attacks, ransomware, and advanced persistent threats (APTs).
- Monitor firewall performance (e.g., throughput, CPU/Memory utilization) and optimize configurations to handle high traffic volumes while minimizing latency.
- Review and fine-tune the configuration of the firewall's intrusion detection and prevention system (IDPS) to enhance threat detection and response capabilities, ensuring rapid mitigation of potential attacks.
- Collect, analyze, and store firewall logs for auditing and troubleshooting purposes. Perform regular log reviews to detect any suspicious activities or anomalies.
- Perform regular security audits to ensure the firewall complies with organizational policies, regulatory requirements, and industry best practices (e.g., GDPR, PCI-DSS, HIPAA).
- Ensure high availability and disaster recovery configurations are in place for the firewall, testing failover mechanisms and backup strategies to guarantee network resilience.
- Update firewall configuration documentation and provide regular status reports on system health, policy changes, and threat management.
- Provide detailed reports on maintenance activities, incidents, updates, and system performance.
- The vendor must also provide necessary spare parts for the service throughout the contract period.

3. Cisco Identity Services Engine (Cisco ISE)

- Provide ongoing maintenance and technical support for Cisco ISE version 3.3.

- Perform software updates, patches, and security fixes as released by Cisco to ensure the platform remains current and secure.
- Ensure compatibility with existing network infrastructure and policies.
- Troubleshoot and resolve issues related to Cisco ISE functionality, performance, or integration with other network systems.
- Conduct regular system health checks to monitor performance, usage, and system logs.
- Assist in the review and optimization of access policies and configurations.
- Support the implementation of updates to authentication, authorization, and accounting (AAA) policies.
- Provide access to Cisco Technical Assistance Center (TAC) for advanced troubleshooting and vendor-level support.
- Provide detailed reports on maintenance activities, incidents, updates, and system performance.

The Contractor shall provide following technical support:

- The Contractor shall provide technical support via phone to address any immediate technical inquiries, troubleshooting, and product-related issues.
- The Contractor shall provide on-site support, providing Cisco certified technicians to resolve more complex issues, perform hardware replacements, or conduct system checks when it is required. If the technical issues or hardware failure cannot be resolved on-site, the Contractor must escalate the issue directly to the manufacturer and arrange for the manufacturer's technicians or engineers to resolve the issue or facilitate any necessary parts replacements.
- The Contractor shall be able to provide genuine hardware spare parts for Cisco products, including critical components for the Cisco Next-Generation Firewall and Cisco Catalyst 9400 Core Switch. The Contractor shall ensure that the spare parts are available locally or can be delivered promptly to minimize downtime in case of hardware failures. The Contractor shall have proven record of sourcing and providing genuine spare parts for Cisco products, including the Cisco Next-Generation Firewall and Cisco Catalyst 9400 Core Switch. The Contractor shall have direct access to genuine Cisco spare parts and provide timely replacement or repair services for defective components.
- Warranty and Service Level Agreements (SLAs): The Contract must provide local warranty services and adhere to agreed-upon Service Level Agreements (SLAs) for both hardware and software. This shall cover hardware replacement, emergency support, and product updates within the region.
- The Contractor must comply with all local laws, regulations, and industry standards for product delivery, installation, and maintenance services, ensuring that the solution meets the region's legal and security requirements.
- The Contractor shall be an authorized distributor or partner of Cisco products, specifically for the Cisco Next-Generation Firewall and Cisco Catalyst 9400 Core

Switch and the Contractor's office shall locate in Bangkok or surrounding provinces and be capable of delivering services quickly and efficiently. The Contractor shall be Cisco Gold Partner or equivalent, demonstrating the highest level of expertise and certification with Cisco products, to ensure that the Contractor has necessary knowledge, skills, and resources to support and implement Cisco solutions effectively.

- Technical support via phone and on-site support shall be available during the U.S. Embassy Bangkok regular business hours for 8 hours a day, 5 business days a week, ensuring assistance during Bangkok regular business hours. The Contractor shall provide localized product support, including timely updates, patches, and critical security alerts for the Cisco Next-Generation Firewall and Cisco Catalyst 9400 Core Switch, in alignment with regional time zones and operational requirements. The Contractor shall provide one year of technical support via phone and on-site support for both hardware and software, including necessary updates, troubleshooting, issue resolution, and escalation support as required. During this period, the Contractor shall maintain hardware and software, provide regular updates, address any performance issues, and escalate any unresolved issues to the manufacturer if necessary. The Contractor shall ensure minimal downtime and optimal performance of support services of the Cisco Next-Generation Firewall and Cisco Catalyst 9400 Core Switch.

II. DELIVERY LOCATION AND TIME

B. The Contractor shall deliver all items not later than 30 days after date of contract award.

C. Any Contractor personnel involved with the delivery of the items shall comply with standard U.S. Embassy regulations for receiving supplies. The Contracting Officer's Representative (COR) will be responsible for instructing contractor personnel at the time the software and maintenance services are delivered.

D. If services will be provided at the U.S. Embassy, the services shall be provided between the hours of 8:00 – 11:30 AM or 13:00 – 16:00 PM (Bangkok local time) from Monday to Friday except the Government's holiday. For on-site services, below information shall be sent to weerasaky.ca@afirms.org prior to service date to schedule the service:

E. The Contractor shall be responsible for processing licenses to be compliance with Thai customs regulations.

F. The Contractor shall be responsible for software installation and configuration, ensuring proper setup, seamless network integration, and optimal performance in line with the Government's requirements. The Contractor shall provide technician support if any technical issues occur during the installation and configuration process. The Contractor must also provide basic configuration guidance resources, such as links to manufacturer's websites to obtain official configuration documents and videos.

G. The Contractor must provide delivery completion documentations for software delivered under this contract. At a minimum, the closeout documents must include:

- 1) Comprehensive Bill of Material for all hardware and software delivered under the contract. The list shall include Item Description, Name of Manufacturer, Model Number, Serial Numbers (if applicable), Delivered Quantity, Unit Price, Extended Price, Warranty Start and Expiration Date, and Subscription Start and Expiration Date.
- 2) OEM manuals for software delivered under this project.

3) Warranty and Technical Support documentation. Documentation shall include an explanation of coverage, the process of obtaining warranty or technical support services, and applicable contact information.

QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

(f) If the Offeror selects “is” in paragraph (d)(1) and “partial or no exemption” in paragraph (d)(2) of this provision, the Offeror will be subject to withholding in accordance with the clause at FAR 52.229-12, Tax on Certain Foreign Procurements, in any resulting contract.

(g) A taxpayer may, for a fee, seek advice from the Internal Revenue Service (IRS) as to the proper tax treatment of a transaction. This is called a private letter ruling. Also, the IRS may publish a revenue ruling, which is an official interpretation by the IRS of the Internal Revenue Code, related statutes, tax treaties, and regulations.
